Minutes of last meeting and matters arising

Minutes of meeting of September 13 2018 were approved.

Matters arising:

Re item 5: East Devon River catchments conference in association with AONB was well attended with some useful collaborations emerging to further the aims of the project.

2. **Finances**

Current balance £991.71.

Recent payments include £98 for TTH leaflet, meeting venues including admin cots. Cosmic has suggested applying an SSL certificate to the website at a cost of £120 pa.

Agreed this was too expensive.

Live Facebook feed is no longer supported on the home page since FB has changed its policy re group page feeds

3. Action group reports and feedback on specific issues

a Traffic, Transport, Highways – action re cancelled Clayhidon meeting.

Meeting planned in Clayhidon on 16 Oct with MP Neil Parish and Highways officers was cancelled. Noted that signage on Somerset approaches to Clayhidon area is much improved. No apparent action on Devon approaches. Agreed that while Clayhidon is seeking to reschedule the meeting, issues are much wider and should address cross border problems of HGV traffic, community transport, little or no funding in either county, Somerset resolution to stop gritting most roads in the Blackdowns (post meeting notification that some of the cuts have been reinstated) AGREED that BHPN should take this up with Neil Parish, at the approaching meeting on November 16, backed up by the TTH leaflet.

B Planning – updates on Blackborough House application

The decision has been delayed from 30/9/2018 to 31/1/2019 due to the Secretary of State's requirement for an EIA. The owner is in dispute with MDDC over the necessity for this, in the meantime the AONB has submitted another comment without reference to the AONB management group.

Regarding the remit and role of the AONB management group. Tim Youngs is drafting new guidelines to clarify.

Clayhidon is asking for a review of a house sale in the parish, irregular planning procedure.

c Broadband- briefing in advance of meeting at 2.30 with CDS and Gigaclear plus parish reps.

GL heard from the CDS rep Matt Barrow yesterday that he was not coming and took a call from the Gigaclear rep invited by Matt during this meeting, also notifying the steering group that they would not be coming. Following the subsequent meeting attended by parish reps, AW to write report on this outcome for the press. GL/CB to AW/GL/CB attempt to rearrange the meeting.
